



Privacy policy LOVE MY VEGGIES

This privacy policy applies to all personal information and data used by LOVE MY VEGGIES for their relations (as clients and suppliers).

In case of a customer order or other, you authorise LOVE MY VEGGIES for processing your personal data.

Our advice is to take notice of the statements below:

PERSON RESPONSIBLE

The responsible person for processing of personal data is in principle: an employee of LOVE MY VEGGIES, established at de Tweede Brikzeilhof 4, 1319 ES Almere, accessible by the e-mail adress info@lovemyveggies.nl.

PROCESSING

In the context of a customer order or otherwise, LOVE MY VEGGIES may use one or multiple data listed below. This includes:

- first- and surname
- gender
- (post)address(es)
- phonenumber(s)
- e-mail adress and data
- bank account number

In addition to this, there is the possibility that other data are collected for excecuting the activities for the order provided.

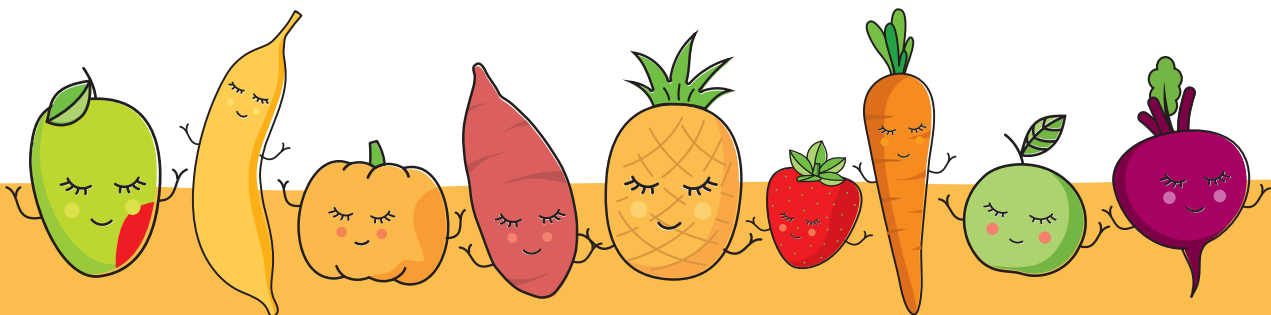
PURPOSE

The purpose is at all times to process the customer order or another assignment that was specifically made between the customer/ client relation and the employee of LOVE MY VEGGIES in good order.

Another purpose can be the recieving of a 'LOVE MY VEGGIES' newsletter that the concerned has signed up for and can always sign out again.

Lastly there is the possibility that customers will be contacted personally for an individual advice.

The data will never be sold to or send to other partys without explicit consent of the person concerned. However, the data can be used by other employees within LOVE MY VEGGIES.





NOTICE AND REPEAL

Concerned can have their data be deleted at any time. For this purpose, men can submit a written request through the mail or as e-mail message, addressed to the data above.

To opt-out of the newsletter, the sign-out link at the bottom of the newsletter can be used. This results in deleting the name and e-mail adress from the mailinglist.

RETENTION PERIODS

LOVE MY VEGGIES stores the personal data for an unknown time limit, this because the information can be important at long-term. These long-term causes include but are not limited to changes or service & support. This does not contain privycsensitce information, however this does contain personal information.

The concerned can submit a written request at all times, with a request to store the data for a maximum period of time. In that situation, a statement will be drafted in which the explicit time period is named. This statement will be signed by the responsible and the concerned.

SECURITY

For protection of the personal data, LOVE MY VEGGIES had a strict policy containing safety, like updates, personal passwords, securityprogramms, two-step authentication, awareness, informing their customers about phishing and other cybercrime.

INSIGHT, DELETING, TRANSMISSION, COMPLAINTS AND QUESTIONS

A request to see, recieve, change or delete the personal data, can be submitted to the general e-mail adress info@lovemyveggies.nl. In the situation of objection to the processing of the personal data, this can be send to info@lovemyveggies.nl at all times;

All requests named above, will be followed up within in a reasonable period of time, at its limit witin a month. In the situation that this timeperiod is not reasonable, the concerned will be informed about this on time and processing will be done witin 3 months after recieving.
